INFORMED CONSENT

Such exemption does not include damages that may be considered fault or negligence of the Organization.

6. - That the client is obliged to attend and follow the instructions of the guides and monitors in the development of the activity, since the safety of the activity depends, to a large extent, on following its instructions and guidelines. Respect at all times the environment and the other components of the activity. Otherwise, the company reserves the right of admission without option to returns of any client who does not comply with the prevention regulations for the development of the activity (ies) and the required hygienic-sanitary regulations derived from the risk. of contagion of COVID-19.
